SUBJECT: NOTICE FOR SUBMISSION OF NOMINATIONS FOR SCCI ELECTIONS 2026–2028

In continuation of the Election Notice issued vide No. 482/SC/ELE 26 – Election Notice dated 16th July 2026 and Corrigendum No. 553/SC/ELC 26 – Corrigendum Pro. VL dated 01st August 2026 and consequent upon the issuance and submission of the Final Voters' Lists in compliance of Order No. 39/2026, Consolidated order No. 40/2026 and Order No. 41/2026, issued by the Regulator vide F. No 6(25)/2026-TO dated 17th August 2026 and in accordance with Rule 18(8) of the Trade Organizations Rules, 2013 (TOR), read with Article 23(8) of the Articles of Association (AoA) of the Sarhad Chamber of Commerce and Industry Peshawar (SCCI), the final voters' lists for the SCCI Elections 2026–28 have been displayed on the official Notice Board of SCCI and published on the official website of SCCI.

2. Consequently, the following is hereby notified for the information and necessary action of all eligible voters:

- i. Any valid voter appearing on the Final Voters' List of the respective representative class, i.e., Corporate Class or Associate Class, may, within four (04) days of the display of the Final Voters' List, obtain the prescribed Nomination Paper(s) from the office of the undersigned and submit the duly completed Nomination Paper(s) to the undersigned on or before **Monday, 24th August, 2026**, up to **02:00 PM**, along with copies of the valid CNICs of the Candidate, Proposer and Secunder and a **non-refundable nomination fee of PKR 10,000/-**, as prescribed under Clause 43 of the AoA of SCCI, through a **Demand Draft or Pay Order** drawn on a scheduled bank in favour of the **Sarhad Chamber of Commerce and Industry, Peshawar (SCCI)**, as prescribed nomination fee as per clause 43 of AoA of SCCI.
- ii. A Candidate may be nominated by not more than **three (03) Nomination Papers** from the same business concern / firm in respect of the same class. Not more than one (01) nomination fee shall be required where a Candidate is nominated through more than one (01) Nomination Paper from the same business concern / firm for a seat of the same class.
- iii. A copy of the final list of voters shall be provided to each contesting candidate. Additional copy or copies of the final list of voters shall be provided upon payment of **non-refundable nomination fee of PKR 1,500/-**, as prescribed under Clause 43 of the AoA of SCCI.
- iv. No candidate shall contest election for more than one (01) seat of the Executive Committee; however, such candidate(s) may withdraw from all or any of the seat(s) of their choice.
- v. All Guidelines and Instructions printed on the reverse/overleaf of the Nomination Paper(s) shall form an integral part of the Nomination Paper(s) and shall be complied with accordingly, particularly Paragraphs 1, 2, 6 to 18, 23 and 24 thereof.
