- The candidates who have been nominated as validly nominated candidates from different classes (i-e Corporate and Associate), in light of Order 53/2024 (iii) are not allowed to contest election on more than one executive committee seat, hence, they are directed to retain only one (01) candidature of their choice, and to withdraw all others. In this manner any candidate, including Mr. Abid Salam, of same nature is directed to comply the order in letter and spirit, thereof.
- As the Regulator has decided on the appeals on 13<sup>th</sup> September 2024, the withdrawal from candidatures shall now be received till **Monday, 15<sup>th</sup> September 2024 till 05:00 PM**, for issuance of Final List of Candidates for SCCI Election 2024-2026 as per announced Election schedule i-e Thursday, 19<sup>th</sup> September 2024.
- Alternatively, in compliance of the Order No 51/2024; 52/2024; and 53/2024, the Preliminary list of candidates, after incorporating the changes through this corrigendum and withdrawal from candidature, shall be deemed to be the final list of candidates, to contest as candidates for **SCCI Election 2024-26** to be held on **Wednesday 25<sup>th</sup> September 2024**.
- Tuesday, 17<sup>th</sup> September 2024 shall be **Public Holiday** on account of Eid Milad-un-Nabi (PBUH).
