7. In respect of the Nomination Papers received and scrutinized for the Associate Class, the Nomination Papers appearing at Serial Nos. 01, 21 and 42 stand Rejected. All other Nomination Papers found valid upon scrutiny stand Accepted.
8. Any candidate having an objection to the nomination of any validly nominated candidate may file an objection before the Election Commission till Thursday 27st August 2026 in pursuance of Rule 18(12) of TOR, read with Article 24(6) of the AoA of SCCI.
9. Alternatively, if no objection is preferred before the Election Commission and subsequently no appeal is preferred thereafter before the Regulator within the prescribed timelines, the List of Validly Nominated Candidates shall be deemed to be the Final List of Candidates on Friday 11th September 2026, for the election scheduled to be held on Thursday 17th September 2026.
10. No Candidate shall contest the election for more than one (01) seat of the Executive Committee. Where a Candidate has been validly nominated for more than one seat, such Candidate may withdraw his/her candidature from all or any of such seat(s), within the date and time prescribed in the approved Election Schedule for the SCCI Elections 2026–2028.
