CORRIGENDUM

3. Consequent upon the above, the List of Validly Nominated Candidates issued vide the aforementioned notification shall stand modified only to the extent of the exclusions specified hereinabove. All other candidates appearing therein shall continue to remain Validly Nominated Candidates, subject to the subsequent stages of the approved Election Schedule for the SCCI Elections 2026–2028.

4. This Corrigendum shall be read together with and form an integral part of the List of Validly Nominated Candidates issued vide No. 613/SC/ELE 26 –Validly Nominated Candidates dated 25th August 2026. All other contents thereof shall remain unchanged and in force.

5. Any candidate aggrieved by a decision of the Election Commission may prefer an appeal before the Regulator on or before Tuesday 1st September 2026, in pursuance of Rule 18(13) of TOR, read with Article 24(7) of the AoA of SCCI.

6. In the event that no appeal is preferred before the Regulator within the prescribed timeline, the List of Validly Nominated Candidates, as modified by and read together with this Corrigendum, shall be deemed to be the Final List of Candidates on Friday 11th September 2026, for the election scheduled to be held on Thursday 17th September 2026.

7. No Candidate shall contest the election for more than one (01) seat of the Executive Committee. Where a Candidate has been validly nominated for more than one seat, such Candidate may withdraw his/her candidature from all or any of such seat(s), within the date and time prescribed in the approved Election Schedule for the SCCI Elections 2026–2028.
