In pursuance of Rule 14(1)(b) of the Trade Organizations Rules (TOR) 2013 and Article 20(1) of the Articles of Association (AoA) of the Sarhad Chamber of Commerce and Industry, Peshawar (SCCI), the Executive Committee, in its meeting held on 15th July 2026, approved the Election Schedule for the SCCI Elections 2026–2028.

5. Upon receipt of your written consent, your appointment shall be governed by all other provisions of Rule 16(c) to (f) of TOR 2013 and Article 22(1)(c) to (f) of AoA of SCCI, which shall form an integral part of this appointment.
