MEMO: RESULT OF SCCI ELCTION 2026-28

In pursuance of Rule 18(15) of TOR and Article 24(9) of AoA of SCCI and Rule 21(5)(a), (b) and (c) of TOR and Articles 13(2)(a–c), 15(1) and (2) of AoA of SCCI and approved Election Schedule for SCCI Elections 2026-28, polling for election of Members of the Executive Committee from the Corporate Class and Associate Class was been held on Thursday 17th September 2026, from 0800 hours to 1700 hours without break and observed by the Observer SCCI Election 2026-28.

- All the polling process and counting of votes was duly conducted in accordance with the Standard Operating Procedures (SOPs) issued by the Directorate General of Trade Organizations (DGTO) vide F.No. 1(1)/2026-Admn dated 31st July 2026 regarding Conduct of Elections.
- The counting of votes, under rule 17(e) and 19(11) of TOR and Articles 25(11) of AoA was undertaken immediately after the polling hours under supervision of polling officer in presence of candidates and their polling agents and observed by the Observer SCCI Election 2026-28.
- In terms of Rule 19(9) of TOR and Article 25(9) of the AoA of SCCI, the challenged votes were considered and amicably decided by the Election Commission and the authorized Polling Agents of the candidates, after verification of the requisite information and prior to declaration of the provisional results.
- The Provisional result was declared in light of Rule 19 (12) of TOR and Article 22(2)(e) and 24(10) of AoA by the Election Commission upon completion of the counting of votes.
- After completion of counting and compilation of results, all record pertaining to the elections was duly signed and sealed by the Election Commission, secretary general and polling agents and handed over to the undersigned, in terms of Rule 19 (14) of TOR and 25(14) of AoA of SCCI.
- The results of votes obtained by the candidates contesting the Corporate Class and Associate Class seats of the Executive Committee in SCCI Elections 2026–2028 are as follows:
