MEMO: RESULT OF WOMEN RESERVED SEATS IN SCCI ELECTIONS 2026-28

In pursuance of Rules 21(4) and 21(6) of TOR and Article 13(2)(d)(i) of AoA of SCCI and approved Election Schedule for SCCI Elections 2026-28, polling for election of Members of the executive committee against Women reserved seats was held on Saturday 19th September 2026, from 1100 hours to 1130 hours.

2. The newly elected Executive committee, being the prescribed electoral college for election against the Women reserved seat in terms of the aforesaid provisions of the TOR and AoA of SCCI, participated in the election, accordingly.
3. All the polling process and counting of votes was duly conducted in accordance with the Standard Operating Procedures (SOPs) issued by the Directorate General of Trade Organizations (DGTO) vide F.No. 1(1)/2026-Admn dated 31st July 2026 regarding Conduct of Elections.
4. The counting of votes, under rule 17(e) and 19(11) of TOR and Articles 25(11) of AoA was undertaken immediately after the polling hours under supervision of polling officer in presence of candidates and their polling agents and observed by the Observer SCCI Election 2026-28.
5. The Provisional result was declared in light of Rule 19 (12) of TOR and Article 22(2)(e) and 24(10) of AoA by the Election Commission upon completion of the counting of votes.
6. After completion of counting and compilation of results, all record pertaining to the elections was duly signed and sealed by the Election Commission, secretary general and polling agents and handed over to the undersigned, in terms of Rule 19 (14) of TOR and 25(14) of AoA of SCCI.
7. The results of votes obtained by the candidates contesting the on two (02) Women Reserved seats of the Executive Committee in SCCI.

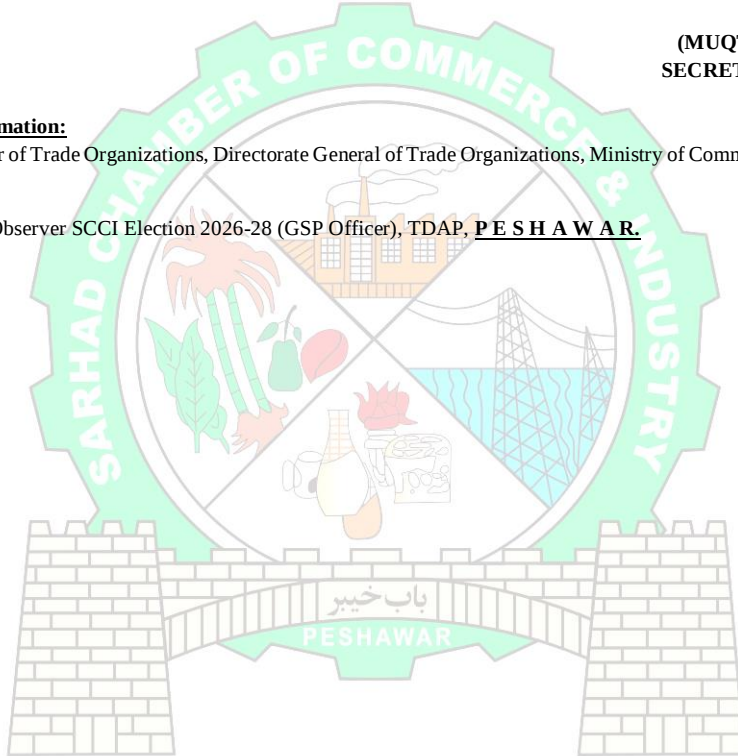
