SUBJECT: **NOTICE OF SCCI ELECTIONS 2026–2028**

In pursuance of section 11 of the Trade Organizations Act (TOA), 2013, read with Rules 13(b) of the Trade Organizations Rules (TOR), 2013 and Article 20(1) of the Articles of Association (AoA) of the Sarhad Chamber of Commerce and Industry Peshawar (SCCI), notice is hereby given under Rule 14(1) of the TOR 2013 and Article 20(3) of AoA of SCCI that the Election Schedule for the SCCI Elections 2026–2028 has been duly approved by the Executive Committee in light of Rule 14 of TOR 2013 and Article 20(1) of AoA of SCCI in its meeting held on 15th July 2026 and the elections shall be conducted in accordance with the approved Election Schedule.

2. The Election Schedule has been displayed on the Notice Board and official website of the SCCI and communicated to the Regulator in accordance with the Rule 14(2)(a) to (c) of TOR 2013 and Article 20(2)(a) to (c) of AoA of SCCI.

3. Elections shall be held for the following seats on the Executive Committee:

4. Sequel to above, upon completion of their term or early retirement for any reason whatsoever, the twenty-three (23) members of the Executive Committee, elected vide notification no, 4951/SC/ELC-24/ Final Result SCCI Election 2024-26 dated 26th September 2024 shall retire on 30th September 2026 and shall not be eligible to contest the elections or co-option any representative capacity in SCCI and shall observe a cooling-off period for the next two (02) year, subject to the provisions under Section 11 of TOA 2013, Rule 21(15) of TOR 2013 and Article 17(4) of AoA of SCCI.

5. In accordance with provisions of Section 11(7) of TOA 2013, Rule 15 of TOR 2013 and Article 21 of AoA of SCCI, only those members fulfilling the prescribed eligibility criteria shall be entitled to vote in the SCCI Elections 2026–2028.

6. All members are advised to comply with the approved Election Schedule, prescribed timelines and applicable election procedures.
