MEMO: SCRUTINIZED LIST OF VALIDLY NOMINATED CANDIDATES FOR OFFICE BEARERS

In terms of Rule 18(16) of TOR and Article 24(11) of the AoA of SCCI, the Nomination Papers for election to the office President, Senior Vice President and Vice President were issued to and received by the Secretary General from amongst the elected Members of the Executive Committee on Saturday 19th September 2026, from 1200 hours to 1700 hours in accordance with the approved Election Schedule for the SCCI Elections 2026–2028 as notified vide No. 4673/SC/ELE 26 – Notification of Returned Candidates dated Saturday the 19th Sept 2026.

2. The Nomination Papers so received were duly scrutinized by the Election Commission under Rule 18(17) of TOR and Article 24(12) of the AoA of SCCI, on Monday 21st September 2026. Consequently, the following shall constitute the Final List of Candidates for the Office-Bearers.

3. The details of the six (06) Nomination Papers scrutinized for the offices of President, Senior Vice President and Vice President are as follows:

4. Sequel to above, the Office-Bearers shall be elected in accordance with the rotational principle prescribed under Rules 11(7), 21(9), 21(10) and 21(11) of TOR, read with Articles 16(1) and 16(2) of the AoA of SCCI.

5. As only **one (01) candidate for each office**, i.e., President, Senior Vice President and Vice President, stands validly nominated in the Scrutinized List of Candidates for Office-Bearers, the number of candidates does not exceed the number of seats for the respective offices. Accordingly, in terms of the proviso to Article 24(12) of the AoA of SCCI, the candidates shall be deemed to have been **Elected Unopposed**. However, the prescribed proceedings under Rule 18(18) of TOR, read with Article 24(13) of the AoA of SCCI, shall be undertaken on Tuesday 22nd September 2026, in accordance with the approved Election Schedule for SCCI Elections 2026–2028.

6. Accordingly, **Mr. Imran Ishaq** is declared to have been **Elected Unopposed** as **President SCCI**, for the term 2026–2028.

7. **Mr. Naeem-ur-Rehman** is declared to have been **Elected Unopposed** as **Senior Vice President SCCI**, for the term 2026–2028.

8. **Mr. Pervez Awan** is declared to have been **Elected Unopposed** as **Vice President SCCI**, for the term 2026–2028.

9. The tenure of offices of all elected Office Bearers shall be two (02) years, in terms of Section 11 of TOA, Rule 21(12) of TOR and Articles 17(1) of AoA of SCCI and shall commence on **01st day of October 2026** and shall conclude on **30th day of September 2028**, for a fixed term of two (02) years in terms of Section 11 of TOA, Rule 21(12), (13) and (14) of TOR and Articles 17(3) of AoA of SCCI.

10. All other applicable provisions of Rule 21(15) of TOR and 17(4) and 18 of the AoA of SCCI shall apply, as and when required.
