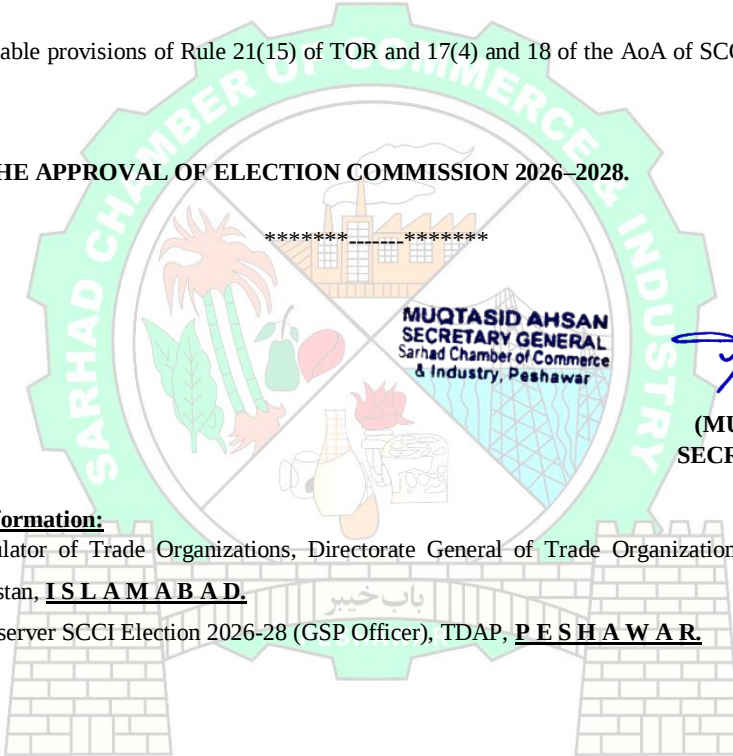

The final results of the election of Members of the Executive Committee and Office-Bearers, in terms of Rule 18(19)(b) of TOR, read with Article 24(14) of the AoA of SCCI, shall be officially announced at the Annual General Meeting (AGM) scheduled to be held on **Thursday, 24 September 2026** at **7:00 PM** at SCCI.

4. The final results so announced at the AGM shall, in terms of Rule 18(21)(a-c) of TOR, read with Article 24(15)(a-c) of the AoA of SCCI, be displayed on the official Notice Board and website of SCCI, and submitted to the Office of the Regulator, respectively.

5. The tenure of offices of all elected Office Bearers and Members of the Executive Committee shall be two (02) years shall commence on **01st day of October 2026** and shall conclude on **30th day of September 2028**, for a fixed term of two (02) years in terms of Section 11 of TOA, Rule 21(12), (13) and (14) of TOR and Articles 17(1-3) of AoA of SCCI.

6. All other applicable provisions of Rule 21(15) of TOR and 17(4) and 18 of the AoA of SCCI shall apply, as and when required.
