In the event no appeal is preferred, or subject to the decision of the Regulator on any appeal so preferred, the Provisional Voters' List, as amended through this Corrigendum, shall constitute the **Final Voters' List** for the SCCI Elections 2026–2028 and the members appearing therein shall be eligible to vote and to contest the election, in their respective class, scheduled to be held on **Wednesday, 17th September, 2026.**
